



**ALBERTA BASKETBALL OFFICIALS ASSOCIATION
FIBA REFRSEHER EXAM 2008-09**



1. Y N Coach B comes onto the floor to attend to injured B5. After 35 seconds, B5 is ready to play. Coach B requests that B5 stay in the game at the expense of a time out. Shall play resume immediately?
2. Y N A4 attempts a try for goal. While the ball is in the air, B5 fouls A5. This is Team B's 4th foul in the quarter. The shot by A4 is successful. Is the official correct in counting the basket and awarding the ball to Team A for a throw-in?
3. Y N The officials erroneously fail to award A4 with two free throws. Team A inbounds the ball and B4 intercepts a pass between A5 and A6. B5 dribbles, attempts a try for goal and is unsuccessful. A4 rebounds the ball, throws a long pass to A6 who scores a basket. The error is then discovered. Should the error be corrected and should A4 be awarded two free throws ?
4. Y N A4 is awarded two free throws. A4 is successful on the first free throw. Before the ball is handed to A4 for the second free throw, Coach A is assessed with a technical foul. The official awards the final free throw to A4 with no line up, followed by two free throws for Team B and possession to Team B at the division line. Is this correct ?
5. Y N With 1:50 remaining in the 4th quarter, A4 scores a basket. Substitute B10, having reported to the scorer's table, is waiting to enter the game. Is the official correct in allowing B10 into the game at this time ?
6. Y N During a sideline throw-in from the back court near the division line, A4 takes one step towards the front court and releases the ball to A5 in the back court. When A4 released the ball, he was in the front court area. Has A4 committed a back court violation ?
7. Y N During a fight, Assistant Coach A leaves the team bench area to help restore order. Shall assistant Coach A be disqualified ?
8. Y N A4 is awarded two free throws. On the first attempt, the ball touches the ring and bounces above it when B4 slaps the ball away. Should A4 be credited with one point ?
9. Y N The throw-in pass from A4 to A5 is deflected by B4. While attempting to retrieve the loose ball, A5 fouls B5. This is team A's 5th foul of the quarter. Shall B5 be awarded two free throws ?
10. Y N During a time-out, A10 reports to the scorekeeper to substitute and then returns directly to the huddle. When play resumes, A10 comes directly onto the court as one of the five players. Is this substitution procedure legal ?
11. Y N Team A is granted a time-out. After 30 seconds have elapsed, Team A is ready to play. Shall play resume immediately ?
12. Y N While dribbling in his/her back court, A4 steps on the mid-court line without touching the surface beyond the line. A4 continues to dribble in the back court. Is this a violation ?
13. Y N B4 commits an unsportsmanlike foul on a two-point attempt by A4 and the try is successful. Then A4 commits a technical foul. Shall the official count the basket, cancel the penalties and award possession to Team B for a throw-in from behind the end line ?
14. Y N A5 passes the ball from the backcourt to A4 who has one foot in the frontcourt and one foot in the backcourt. Shall the official end the 8 second count?
15. Y N With less than two minutes to play in the game, the clock is stopped because of a field goal by A4. Team B requests a time-out. Shall the request be granted ?
16. Y N Dribbler A4 loses control of the ball. A5 then fouls B5. Is this a team control foul ?
17. Y N Once a player has assumed an initial legal guarding position, may that player legally move laterally, without regard to time or distance, directly into the path of an opponent who is dribbling the ball ?
18. Y N May unused timeouts from the first overtime be carried over into any subsequent overtime period ?
19. Y N On a final free throw, B4 commits a lane violation and then free thrower A4 violates. The officials call a double violation and award a throw-in according to the alternating possession process. Is this correct ?
20. Y N Players A4 and B4 commit a double foul while Team A is in control of the ball. Shall the shot clock be reset ?
21. Y N Team A has been in control of the ball for 14 seconds when an official stops play to attend to injured player A4. When play resumes, shall the shot clock be reset to 24 seconds ?
22. Y N Player A1 is assessed his third technical foul during the game. By rule, shall A1 be ejected ?
23. Y N Defensive player B1 leaps from his front court, intercepts a pass thrown by A1, and lands in his back court. Is this a violation ?
24. Y N A4's try for goal is in the air when the signal sounds to end the period. The ball hits the ring and bounces above it when B4 bats the ball away. Has B4 committed interference ?
25. Y N Team A has three timeouts left in the second half. Coach A requests a timeout. At the end of the timeout, Coach A requests another timeout. Shall the request for a second consecutive timeout be granted ?
26. Y N While airborne, A4 catches the ball, lands on one foot, jumps off that foot, lands on both feet, jumps and releases a try for goal. Is this a violation ?

27. Y N A5 releases a try for a goal. The ball misses the ring, after which a held ball occurs between A2 and B2, before either team can again establish control. The alternating possession arrow favours Team A. Shall the shot clock be reset ?
28. Y N Does team control end as soon as the ball is released on a try for goal ?
29. Y N B5 is assessed a technical foul. Can substitute A10 enter the game and shoot the two free throws resulting from B5's technical foul ?
30. Y N A4 is erroneously awarded two free throws. A4 misses both free throws and during the rebounding activity after the second free throw, A5 fouls B5. The foul is not unsportsmanlike. The error is then discovered. Should the A5's foul be cancelled ?
31. Y N A4 is charged with a technical foul. Coach B is then also charged with a technical foul. Shall the penalties cancel each other ?
32. Y N A1 scores a 3-point field goal but the scorer incorrectly counts it as a 2-point basket. The error is discovered before the signing of the score sheet. Shall the error be corrected ?
33. Y N After 50 seconds have elapsed in a charged time-out, the timekeeper sounds the warning horn. Ten seconds later, the timekeeper sounds the horn to indicate the end of the time-out. B-10 then reports to replace B4. Shall B10 be allowed to enter the game ?
34. Y N During the initial jump ball, jumper A4 legally taps the ball. B5 leaps from Team B's front court, catches the ball in the air and lands in Team B's back court. Is this a violation for illegally returning the ball to the back court ?
35. Y N B4 commits an unsportsmanlike foul on dribbler A5. Before the ball becomes live for A5's first free throw, A4 is called for a technical foul. The officials rule that the two penalties cancel each other. The possession arrow favours Team B. The officials decide that play should resume with a throw-in by Team A. Are the officials correct ?
36. Y N With 6 seconds expired of the 8 seconds to advance the ball from his back court, A4, from his back court, deliberately bounces the ball off the leg of B4 who is in Team A's front court. The ball bounces back to A4 who recovers the ball in his back court. Does A4 have a new 8 seconds to advance the ball to the frontcourt?
37. Y N On a final free throw by A4, after the ball has struck the ring, defensive player B4 tips the ball into the basket, while attempting to clear the rebound. The official counts the free throw and credits A4 with one point. Is this correct ?
38. Y N The ball is within the basket on a shot by A4 when A5 contacts the net. Is this offensive interference?
39. Y N After Team A has scored a field goal, no Team B player moves to get the ball for a throw-in, intentionally delaying returning the ball into play. Should the official place the ball on the floor outside Team B's end line and begin a 5-second count ?
40. Y N While the ball is in the air as a result of a try for goal by A4, the 24-second signal sounds. The ball strikes the ring and bounces above it with still the possibility to enter the basket, when B2 knocks the ball off the rim. Has B2 committed interference ?
41. Y N A1 commits a technical foul in the 1st period. In the 4th period, A1 commits an unsportsmanlike foul. By rule, shall A1 be disqualified ?
42. Y N A1 is injured and receives treatment. A10 substitutes for A1. Team A is granted a time-out. At the end of the time-out, A1 has recovered and is ready to play. A1 requests that he be allowed to re-enter the game. The official does not allow A1 to re-enter the game at this time. Is the official correct ?
43. Y N During an alternating possession throw-in by Team A, A1 is assessed a foul for an illegal screen. Shall Team A lose its right to the alternating possession ?
44. Y N A substitution opportunity has ended when A10 runs to the scorer requesting a substitution. The scorer reacts erroneously and the horn sounds. The official blows his whistle and interrupts the game. Shall the substitution be granted ?
45. Y N A1 was awarded 2 free throws. Between A1's free throws, Coach A requests a time-out. During A1's last free throw, B1 enters the lane too soon. A1's free throw is missed. The official calls the violation by B1 and awards A1 a replacement free throw. Shall the time-out be granted before the replacement free throw is attempted ?
46. Y N During a free throw by A1, A2 enters the lane from his rebound space before the ball is released by A1. A1's free throw is successful. Shall the free throw be disallowed ?
47. Y N A1 scores a basket. B1 takes the ball out of bounds for the throw-in. B1 bounces the ball out of bounds to B2 who is also standing out of bounds behind the end line. B2 then passes the ball onto the court to B3. Is this play legal ?
48. Y N A1 releases a try for goal. The 24-second signal sounds while the ball is in the air. The ball then misses the ring and is immediately held simultaneously by A4 and B4. The official calls a jump ball. The arrow favours Team A. The official awards an alternating-possession throw-in to Team A. Is the official correct ?
49. Y N A1 jumps to attempt a try for goal. B1 jumps and blocks A1's attempt. A1 lands without having lost control of the ball. Is this a travelling violation by A1?
50. Y N As the horn sounds to end the first period, B1 commits an unsportsmanlike foul on A1. The possession arrow favours Team B. Shall the second period begin with a Team B throw-in according to the alternating process?
